All bids tender documents are to be submitted online only and in the designated cover(s)/envelope(s) on the e-procurement website. Tenders/bids shall be accepted only through online mode on the e-procurement website and no manual submission of the same shall be entertained. Late tenders will not be accepted.

The scanned copy of registration certificate duly attested by a gazetted officer, preliminary agreement in stamp paper worth Rs. 200/- signed by the contractor, Tender documents duly filled, e- payment form duly filled shall be submitted online and subsequently in a separate cover physically superscribing the name of work and tender number to the Executive Engineer, Cochin Devaswom Board, Thrissur through Registered post/speed post before the time of opening of Tender. Hard copies shall be submitted only after submission of online documents.
